Town of Boulder Junction – Broadband Project

Director Van Grinsven reported that there is currently \$3,000 in the High Speed Broadband Fund. Director Govier report that the project is not actively fundraising at this time. Nothing further to report.

<u>Town of Boulder Junction - North Creek Trail Loop Project</u>

Board Member Van Grinsven reported that Camp Holiday launched a \$10,000 matching campaign with their campers that will run through July 6, 2021; they are also hosting a garage sale over Memorial Day Weekend with 100% of the proceeds going to the North Creek Loop Trail Fund.

The Town is investigating the tree removal portion of the trail construction process. The grant requests for Phase II of the project have been submitted to the State and DNR. Grant submissions result will be announced this fall.

As of April 21, 2021, the project has raised \$128,275.50 towards the goal of \$155,000 for Phase 1. North Creek Loop Trails funds remaining after Phase 1 of the project will go toward Phase 2.
