The BJCF is an incorporated 501(c)(3) federal tax exempt public charity.

The true measure of the Foundation's growth is ultimately the community benefit and impact realized through our individual and collective efforts.

Fiscal Year 2012 has been a year of significant growth. As a result of gifts, contributions, and fundraising activities, total assets have grown from \$2,585 to \$24,698 this past year.

In addition, due to the generosity of our donors, more than \$14,650 was deposited into the Boulder Junction Restricted Endowment Fund during 2012, bringing its total assets from \$4,320 to \$19,908 as of December 31, 2012.

The Foundation further achieves its purpose by distributing grants to Boulder Junction's nonprofit agencies, organizations, and educational institutions. In 2012, more than \$2,700 has been returned to Boulder Junction in the form of grants and distributions. The beneficiaries included the Boulder Junction Volunteer Fire Department, the 8th Grade Class at North Lakeland School, the Boulder Junction Christmas Scholarship Fund, the Campership Fund at Camp Manito-wish YMCA, and the BJCF Community Center Building Fund.

Current Funds

BJCF COMMUNITY CENTER BUILDING FUND – Gifts to this fund established in November, 2012, support the construction of the new Boulder Junction Community Center.

> BJCF NEIGHBORS FUND – Gifts to this fund established in May, 2012, support the operations of the Foundation, ensuring the continuation of our work in Boulder Junction.

> > **BOULDER JUNCTION RESTRICTED ENDOWMENT FUND** – The Endowment Fund is managed, invested and kept in perpetuity to provide earnings for the benefit of charitable causes in Boulder Junction. The Endowment Fund is currently held and managed by the Community Foundation of North Central Wisconsin.











Growth of Funds



Fund established October 10, 2010




Fund established in November, 2012
