The mission of our Foundation is to enhance and preserve Boulder Junction for present and future generations. That's a BIG mission, but one the Board of Directors is committed to and passionate about.

Since the Boulder Junction Community Foundation was incorporated in 2010 the following achievements have been reached:

- Achieved classification as a public charity under section 501(c)(3) of the Internal Revenue Code. The Foundation is qualified to receive a variety of tax deductible contributions to the extent allowed by law.
- Established a Restricted Endowment Fund to facilitate our mission efforts.
- Invested in the Boulder Junction community for the following projects: Boulder Junction Community Center, Boulder Junction Library, Ball Diamond, Boulder Junction Fire Department, Boulder Junction Chamber of Commerce, the musical arts, bike trail enhancements, and downtown beautification projects.

With everyone in our community working together the Boulder Junction Community Foundation is almost a third of the way to the lofty goal:

To raise \$1 Million Dollars in our Restricted Endowment Fund so we can give \$50,000 back **EACH and EVERY year...FOREVER.**

TYPES OF FUNDS

Restricted Endowment Fund is managed, invested, and kept in perpetuity to provide earnings for the benefit of charitable causes in Boulder Junction. The fund is held and managed by the Community Foundation of North Central Wisconsin. Grants are available annually through this fund to enhance Boulder Junction for present and future generations. Our goal is to raise \$1,000,000 in this fund to enable the Foundation to give \$50,000 back to the community each year...forever.

Community Enhancement Funds are managed and kept at our local bank to provide grants on an as needed basis for the benefit of charitable causes in Boulder Junction. These funds include: Arts & Culture Fund, Bike Trail Fund, Town Flower Fund, and Greatest Needs Fund.

GRANT GUIDELINES

What We Support

- The Foundation is dedicated to supporting innovative ideas for:
- Projects that enhance the quality of life for Boulder Junction's citizens and visitors.
- Projects that support human services, education, health and recreation, arts and culture, the environment and community development.
- Projects involving nonprofits that strengthen and enhance the Boulder Junction community.
- Projects that protect those characteristics of our community that are so loved.

Who may apply?

The Foundation welcomes grant requests from organized groups throughout the Boulder Junction area, including:

- Charitable organizations classified as 501(c)(3) under the Internal Revenue Code
- Local units of state or national organizations, and independent nonprofit organizations
- Schools, governmental units and religious institutions providing programs benefiting the public at large

Grant Guidelines

Project Eligibility:

- 1. The project addresses unmet needs within the Town of Boulder Junction that are consistent with the charitable purposes of the BJCF. The project clearly falls within BJCF's mission.
- 2. The project is consistent with the mission and purposes of the organization applying for the grant.
- 3. The applicant organization has provided evidence satisfactory to the Board of Directors that it has the financial capacity and the ability to complete the project and, if applicable, provide for its long-term management and maintenance.
- 4. The project can be completed within two years of the grant approval date.
- 5. If a project is a phase or component of a larger project, the component is usable or functional in and of itself.
- 6. The project does not meet any of the criteria of Ineligible projects and project costs under Bylaw X of the BJCF Bylaws. Bylaws available at boulderjunction.org.

The Boulder Junction Community Foundation seeks to promote respect for all people. We do not discriminate on the basis of race, color, religion, gender, national origin, ancestry, age, medical condition, disability, veteran status, marital status, sexual orientation or any other characteristic protected by law; we expect grant applicants to hold similar standards.

2018 COMMUNITY GRANTS

Boulder Junction Chamber of Commerce Music on Main Street

The Boulder Junction Chamber of Commerce was awarded two grants. A grant of \$400 helped fund artists performing at the weekly summer music series. The series hosts eight Wednesday evening performances in June, July, and August. The Foundation also awarded a grant in the amount of \$750 which helped fund the color LED lighting on the Music on Main Street stage. The lighting is a great addition, helping artists who perform and adding ambiance to the performance during the evening. Both grants as well as individual and business donations help to support this event which is now in its 11th season.



Boulder Junction Public Library Children's Summer Reading Program

The Boulder Junction Public Library was awarded a \$450 grant to purchase reading incentive prizes for the Children's Summer Reading Program grand prize raffle drawing. Boulder Junction Public Library's "Libraries Rock" summer reading program laid the groundwork for children to become lifelong readers and learners. Each week 30-40 children participated.

Special program activities included a presentation about animal habitats with a naturalist from the North Lakeland Discovery Center, a visit from Colossal Fossils natural history program, and many other fun and educational games, activities and crafts. The program wrapped up with a dance party, prize awards, and ice cream. The Boulder Junction Community Foundation is a proud supporter of this annual program.

Town of Boulder Junction Flower Baskets on Main Street

A \$750 grant was awarded to beautify Boulder Junction with fresh flower baskets through a donation directed specifically by a donor.








Financials

The Boulder Junction Community Foundation is a 501(c)(3). The Finance Committee and Board of Directors monitor and review the investment management services provided by the Community Foundation of North Central Wisconsin in managing the Boulder Junction Community Foundation Endowment Fund. In 2018, as approved by the Board of Directors, \$40,336 was contributed to the Restricted Endowment Fund, bringing our Fund total at the end of the vear to \$288,779. Community Enhancement Funds (Arts & Culture Fund, Bike Trail Fund, Town Flower Fund, and Greatest Needs Fund) are managed directly by the Board of Directors and held at Huntington Bank in Boulder Junction. At the recommendation of the Foundation's Financial Advisor, Mark Hilgendorf, for the second year, \$2,000 was contributed to our Reserve fund, bringing the year-end balance to \$4,308. Annual contributions of \$2,000 or more are planned to continue until the fund balance is equal to two (2) years of Operating Expenses. Grants totaling \$2,300 were awarded. Our auditors were Peterson Metz. Ltd.
